## Terms and Conditions

### Online Introduction to Passive Fire course:

Only one online 'Introduction to PFP' can be added to your basket per transaction, orders may take up to five (working) days to process. The purchased licence offers access to the course for the named licensee(s) only for up to a maximum of 6 weeks from the date of your first login.

Refunds are only applicable based on the following:

- A refund is requested within one month of purchase (transaction) and the course has not been accessed and/or used.
- A refund is requested within six weeks of issue of username and password and the course has not been accessed and/or used.

### Foundation Course Level 2 and Level 3:

- Once the application has been received please allow up to 5 (working) days for processing, after which delegates will be notified of booking arrangements by the ASFP office.
- Payment terms are strictly 30 days from date of invoice or prior to the start of the first day of the course, whichever is soonest. For online courses, payment is required prior to access to the eLearning.
- Full joining instructions will be sent to delegates and arrive no later than 5 (working) days before the course start date. For eLearning courses, access will be sent to the delegates once payment is confirmed as received into the nominated ASFP bank account.
- All delegates will be supplied with comprehensive course notes. For eLearning courses all appropriate information is supplied within the training platform.

### Cancellations/Refunds:

Classroom Foundation Course:

- 6-4 weeks notice\*: 50% refund.
- 4-0 weeks notice\*: No refund.
- Failure to attend: No refund.
